FUND OVERVIEW

This Fund aims to provide investors with capital growth and recurring income in the medium to long-term[^] through investments in securities of and securities relating to Malaysian companies which offer attractive yields and sustainable dividend payments.

Note:[^]“medium to long-term” in this context refers to a period between 3 to 7 years.

The Fund's asset allocation is as follows:

- 70% to 98% of Net Asset Value (NAV): Investment in equity and equity-related securities of Malaysian companies which offer attractive yields and sustainable dividend payments;
- 2% to 30% of NAV: Investment in liquid assets, fixed income securities, money market instruments and deposits with financial institutions.

The Fund is suitable for investors who:

- Seek a diversified domestic investment portfolio;
- seek capital growth and recurring income in the medium to long-term period;
- seek a steady investment; and
- are willing to accept a moderate risk in their investment.


