The Fund's asset allocation is as follows:


- Up to 100% of the Net Asset Value (NAV): Investments focus on high dividend yielding equities;
- up to 60% of the NAV: Investments in fixed income instruments and/or liquid assets.

The Fund is suitable for members who:




